



Terms & Conditions of Remittance & Money Changer ‘Match Receipt to Win’ (“Match and Win’)

This ‘Match and Win’ campaign is carried out by Network for Electronic Transfers (Singapore) Pte Ltd (“NETS”) and is subject to these terms and conditions (“Terms”).

4. To redeem the \$100 cash prize, the Winner will then have to WhatsApp a photo of the winning NETS receipt to 9148 7840, and include the last 4 characters of their identity no. (E.g: XXXXX123A). NETS will validate the submission and transfer through PayNow \$100 cash prize to the eligible winner within 14 days.
5. There will be 300 winners. Each winner will win the following \$100 cash (“Prize”).
6. Proof of winning receipt must be sent by 5 January 2020 and winners shall comply with any instructions specified by NETS. In the event a winner fails to comply with any other instruction or condition specified by NETS, the Prize may be forfeited at NETS’ absolute discretion.
