



## **Terms and Conditions of Cashier Incentive Programme Islandwide ‘Match & Win’ (“NETS More GET More”)**

This incentive Programme is carried out by Network for Electronic Transfers (Singapore) Pte Ltd (“NETS”) and is subject to these terms and conditions (“Terms”).

1. NETS More GET More is open to all cashiers who receive a Merchant Copy of NETS receipts at participating **NETS tap Accepted** stores (“Cashiers”). NETS may from time to time in its absolute discretion decide on the eligibility for participation in the NETS More GET More.
2. This incentive Programme will take place from 20 April 2020 – 31 December 2021 (“Qualifying Period”). The verification of winners will be held by NETS every Friday at NETS’ premises at 298 Tiong Bahru Road, #04-01/06 Central Plaza Singapore 168730.
3. To qualify for participation in NETS More GET More, each Cashier would have to match the last 3 digits of System Trace Audit Number (“STAN”) code and the approval code on the Merchant Copy of the NETS receipts during the Qualifying Period.
4. Each successful and verified matching pair of the last 3 digits of STAN Code and approval code numbers submitted will be entitled to win a \$100 prize (“Prize”).
5. There will be up to 86 winners, and each winner will stand to win the \$100 Prize for each matching pair of numbers.
6. Upon successful verification by NETS and subject to the winner’s compliance with any instructions specified by NETS, winners will receive the Prize via PayNow/ Bank Transfer within 7 working days.
7. All Singaporeans, permanent residents and foreigners residing in Singapore are eligible for NETS More GET More. Employees of NETS are not eligible to participate in NETS More GET More.
8. Winners shall comply with any instructions specified by NETS. In the event a winner fails to comply with any other instruction or condition specified by NETS, the Prize may be forfeited at NETS’ absolute discretion.
9. By participating in NETS More GET More, winners are also giving consent in releasing their names and contact information (e.g. mobile number, email address and address) to NETS for the purpose of announcing the winners on NETS website, redemption of the Prize and submitting an audited statement of account for the lucky draw the Singapore Police Force under the Common Gaming (Exemption) Notification 1997 / Remote Gambling (Exempt Persons) Order 2015.

11. All winners shall be notified by Whatsapp, phone or email and the results will also be announced on [www.nets.com.sg](http://www.nets.com.sg). NETS decision shall be final and no correspondences will be entertained.
12. In the event a winner fails to collect a Prize within 2 months after each date of verification of winners and/or fails to comply with any other instruction or condition specified by NETS, the Prize may be forfeited in NETS' absolute and sole discretion.

No further correspondence regarding NETS More GET More, these Terms or any decision made by NETS in connection therewith and/or the results will be entertained. NETS reserves its absolute right to determine an outcome and act as it deems fit in any dispute and/or issues relating thereto.
