

Terms & Conditions of NETS Tap & SimplyGo Transit Rebate Promotion (1 Feb 2020 – 31 Mar 2020)

The NETS Tap & SimplyGo Transit Rebate Promotion ("**Rebate Promotion**") is carried out by Network for Electronic Transfers (Singapore) Pte Ltd ("**NETS**") and is subject to these terms and conditions ("**Terms**").

1. The Rebate Promotion is open to the first 18,000 contactless ATM cardholders from DBS/POSB, OCBC, and UOB who spent S\$30 with NETS Tap for transit (public bus & MRT) per month ("**Participant/ Participants**"), which may include the employees of NETS and the 3 banks (DBS/POSB, OCBC and UOB).
2. Qualifying period to earn the Rebates is from 1st to 29th February 2020 for February Rebate and 1st to 31st March 2020 for March Rebate ("**Qualifying Period**").
3. The Rebate Promotion allows Participants to earn S\$5 rebate when they spend S\$30 per month on transit in Singapore using NETS Tap during the Qualifying Period ("**Rebate/ Rebates**").
4. Participants are eligible to only one S\$5 rebate per month.
5. Bank ATM cards accepted for use in the Rebate Promotion are the NETS Tap enabled contactless cards issued by DBS/POSB Bank, OCBC Bank and UOB Bank in Singapore. Please refer to the card images below and look out for the NETS Tap contactless icon to identify eligible bank ATM cards ("**Eligible Cards**").



6. Participants are advised to add/ link their bank ATM card to their TransitLink SimplyGo account on the TL SimplyGo app/ website to keep track of their travel spend using the NETS contactless cards. To sign up for a TransitLink SimplyGo account, visit the TL SimplyGo app/ website.
7. NETS may from time to time in its absolute discretion decide on the eligibility for participation in the Rebate Promotion.
8. Tap in and out using the same card and take out your card from your wallet/ bag to prevent card clash and avoid multiple charges.
9. Participants must have sufficient funds in their bank account to cover their transit costs during the Qualifying Period.



10. Rebates earned will be credited to your registered bank account within 2 to 3 calendar months (i.e. by 31 May 2020)
11. The DBS/POSB, OCBC and UOB ATM cards that are eligible for this Rebate Promotion must not be blocked for use (in good standing) and conducted in a proper and satisfactory manner as determined by the 3 banks in their sole discretion at the time of crediting the Rebate. In the event that the registered card and account is delinquent, voluntarily or involuntarily closed or terminated or blocked for use for any reason whatsoever before the Rebate is credited into the said account, NETS and/or the participating banks reserve the right not to credit the Rebate to the Participant.
12. NETS and/or the participating banks reserve the right to claw-back the Rebate amount without prior notice, at its discretion charging the full retail value of the Rebate amount, if it subsequently determines that the Participant is in fact not eligible to receive the Rebate, including where the Rebate was awarded due to an error or where the transaction was not a transit ride spending.
13. Rebates are not transferable, exchangeable nor redeemable for other rewards.
14. NETS or the participating banks assume no responsibility for any losses, damages or expenses arising in connection with this Rebate Promotion, howsoever arising, including without limitation, from any late or non-notification, any error in computing, technical hardware or software breakdown, malfunctions, defects, failed, delayed or incorrect transactions, lost or unavailable network connections, or any notice that is lost or misdirected, which might affect the Participants' eligibility in the Rebate Promotion.
15. NETS or the participating banks may vary these Terms and Conditions or suspend or terminate the Rebate Promotion without any prior notice or liability to any Participant.
16. NETS or the participating banks decision on all matters relating to the Rebate Promotion shall be final, binding and conclusive for all purposes and in any legal proceedings. No correspondence or claims will be entertained.
